

THE VEND COLLECTIVE (TVC) CONSIGNMENT AGREEMENT

This Consignment Agreement ("Agreement") outlines the terms and conditions for consigning merchandise with The Vend Collective ("TVC"). By signing below, the Consignor acknowledges that they have read, understood, and agree to the following policies.

CONSIGNMENT CATEGORIES

Collective

- Consignors receive **40% of the item's final selling price.**
- Items are subject to a **50% markdown after 30 days**, at TVC's discretion.
- Items are committed to consignment for a minimum of **three (3) months** and may not be withdrawn during this period.

Slowly

- Consignors receive **50% of the item's final selling price.**
 - Items are subject to a **30% markdown after 60 days**, at TVC's discretion.
 - Items are committed to consignment for a minimum of **three (3) months** and may not be withdrawn during this period.

DONATION POLICY

The following donation policy applies to **BOTH SLOWLY & COLLECTIVE.**

- Items **listed by TVC at under \$100** that remain unsold after the three (3) month consignment period may be donated without further notice, unless TVC elects to continue offering the item for sale.
- Items **listed by TVC at \$100 or more** may be requested back after the three (3) month consignment period. The consignor is responsible for contacting TVC to arrange a pickup appointment.

- If TVC does not hear from the consignor after the consignment period has ended, or if the consignor misses their scheduled pickup window, the items will be considered abandoned and may be donated at TVC's discretion.
 - TVC reserves the right to extend the selling period for any item at its sole discretion.
 - Any item found after intake to be stained, damaged, excessively worn, unclean, counterfeit, or otherwise unsuitable for sale may be removed from consignment immediately and donated or otherwise disposed of at TVC's discretion.

INTAKE POLICY

- The initial intake is a preliminary sort only.
 - During processing, TVC may determine that certain items do not meet our quality, merchandising, seasonal, or brand standards.
 - If additional items are declined after intake, TVC may contact the consignor to arrange pickup.
 - All items must be freshly laundered, clean, and in sale-ready condition at the time of drop-off.

PRICING & MERCHANDISING

- All pricing is determined by TVC.
 - TVC reserves the right to price, markdown, display, rotate, merchandise, or promote consigned items as necessary.
 - Due to limited sales floor space, inventory may be rotated between the sales floor and storage.
 - Consigned merchandise may be included in store-wide promotions or special sales.

LIABILITY

- TVC is not liable for normal wear or damage resulting from customer handling or try-ons.
 - While every reasonable effort is made to safeguard consigned merchandise, TVC is not responsible for loss, theft, fire, water damage, accidents, or any other unforeseen circumstances affecting inventory.

CONSIGNOR ACCOUNT

- Consignors may view their inventory, sales, and account balance through the Consignment Portal:

 - Consignor credit receives an additional **10% in value** when redeemed for in-store purchases.

PAYOUTS

- Payouts are issued by **e-Transfer upon request only**.
 - To request a payout, email **vendpayouts@gmail.com**.
 - Payout requests are reviewed on the **15th and 30th of each month**.
 - Please allow several business days after these dates for your e-Transfer to be processed.
 - A **\$1.00 administrative fee** will be deducted from each payout.

AUTHENTICITY

The Consignor confirms that all consigned items are authentic, legally owned, and free of any liens or claims. TVC reserves the right to refuse, remove, or dispose of any item suspected of being counterfeit or misrepresented.
